For 2023 we have seen an increase in Scope 1 and 2 carbon emissions due to business expansion in Bristol.

Carbon Reduction Projects

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2019 baseline.

- 100% renewable electricity supply deal at our Guildford office
- Installed energy efficient LED lighting and controls at our Guildford office
- Implemented a comprehensive environmental management system and obtain ISO14001 certification
- Implemented a flexible working policy to reduce employee commuting emissions
- Introduced salary sacrifice scheme to encourage employee switch to EV

The carbon emission reduction achieved by these schemes and measures will continue to be in effect. In the future we hope to implement further measures such as:

- Encourage and enable low carbon transport options for business travel and commuting including public transport and offsetting
- Switch to 100% renewable energy supplies at all our UK offices
